



## **GOLF CART RENTAL CONTRACT**

1. Lessee acknowledges receipt of the Equipment identified below (the "Equipment") which was examined by Lessee and found to be in first-class condition upon receipt (except as noted below). Lessee further acknowledges that the Equipment is leased by Lessor to Lessee for the use and purpose for which it was manufactured subject, however to the terms and conditions set forth herein.
2. Lessee shall return the Equipment to the Stable Office no later than the date and time specified below (LESSEE SHALL CONTACT LESSOR IF AN EXTENSION OF TIME IS DESIRED) or upon Lessor's demand thereof. The Equipment shall be returned in the same condition as when received, ordinary wear accepted.
3. Lessee shall pay to Lessor, upon demand, rental for the Equipment at the rates provided below until the Equipment is returned to Lessor. Daily rates will apply unless other arrangements are made with Lessor in advance. Daily rates will apply if the Equipment is kept after the scheduled return date. All days including weekends and holidays are chargeable.
4. Lessee shall reimburse Lessor, upon demand, for the loss of, or any damage to the Equipment or property damage while it is rented to Lessee and for all costs and expenses, including reasonable attorney's fee, incurred by Lessor in collecting amounts owed by Lessee hereunder or in otherwise enforcing Lessor's rights hereunder.
6. Lessee shall abide by all rules and regulations of Lessor governing the use of the equipment.
7. Lessee shall not assign this Rental Contract or sublease the Equipment.
8. Lessee shall not allow anyone who has not signed the **GOLF CART WAIVER, ASSUMPTION OF RISK, GENERAL RELEASE OF LIABILITY, INDEMNITY AND HOLD HARMLESS AGREEMENT, AND COVENANT NOT TO SUE** to operate the Equipment.

## **Virginia Horse Center Foundation Golf Cart Rules and Regulations**

1. Never drive recklessly or joy ride. Drive courteously. Obey all Virginia Horse Center Foundation safety rules and Virginia traffic laws.
2. Always be mindful and courteous of horses and riders.
3. **ONLY HOLDERS OF A VALID DRIVER'S LICENSE 18 YEARS OF AGE AND OLDER MAY OPERATE THE EQUIPMENT.**
4. Never drive intoxicated or under the influence of any drug or narcotic.

5. Avoid distractions while operating the golf cart just as you would in an automobile. Be safe and attentive -- avoid talking, texting, or reading, reaching for objects, applying makeup or eating while driving.
6. Only carry the number of passengers for which there are seats.
7. Drivers and all passengers should keep all body parts (arms, legs, feet) inside cart while vehicle is in motion, except when signaling a turn.
8. Do not allow anyone to ride standing in the vehicle or on the back platform of the vehicle. Do not put vehicle in motion until all passengers are safely seated inside vehicle.
9. Operate the vehicle from the driver's side only.
10. Check blind spots before turning.
11. Carefully turn and look behind the golf cart before backing up.
12. Avoid sharp turns at maximum speed and drive straight up and down slopes to reduce the risk of passenger ejections and/or rollover. Use extreme care while driving after dark and avoid excessive speed, sudden starts, stops and fast turns.
13. Reduce speed due to driving conditions, especially on hills or other inclines or declines, near blind corners, intersections, pedestrians, horses and in inclement weather.
14. Do not leave keys in the golf cart while unattended and make sure the parking brake is set.
15. Always yield to pedestrians, horses and be cognizant of motor vehicles.
16. Use extreme caution in inclement weather. Although a golf cart may shield you from the rain, it may not protect you from a lightning strike.
